Fernando Casal Bértoa is an assistant professor in Comparative Politics at the University of Nottingham, member of the OSCE/ODIHR "Core Group of Experts on Political Parties"; Research theme director of the Nottingham Institute for Comparative Economic and Political Research (NICEP). He works occasionally with DRI. He recently published <u>an opinion on populist parties in Europe</u>.

Paul-Jasper Dittrich is a research Fellow at Jacques Delors Institute, working on digitalisation in Europe and studies the political developments through social media and Internet. He published <u>on social networks and populism</u>.

Rainer Faus is the managing partner at Pollytix strategic research, focusing on opinion research in the fields of politics, society and economy, as well as strategic consulting based on qualitative and quantitative research.

Nils Franke is a lecturer at Leipzig University, department of cultural studies, a historian and communication scientist and the author of numerous publications on nature protection

Carmen González-Enríquez is a doctor in Political Science and Sociology, Professor at the UNED's Department on Political Science and Senior Analyst on Immigration at the Real Instituto Elcano. She <u>published</u> on populism in Spain arguing that despite unemployment, inequality and migration there are no right wing populist parties.

Finn Heinrich served as Programme Director for CIVICUS: World Alliance for Citizen Participation and more recently as Research Director for Transparency International. Finn joined Democracy Reporting International in June 2017 as Director of Programmes. He holds a doctoral degree in Political Science and has published widely in research journals on civil society and corruption issues.

Kirsten Hommelhoff is the head of Stiftung Mercator's Mercator Centre Berlin (MCB). She previously worked in different roles for the foundation, most recently as head of the International Affairs division.

Ivan Krastev is a political scientist and the Chairman of the Centre for Liberal Strategies in Sofia, permanent fellow at the Institute of Human Sciences in Vienna, founding board member of the European Council on Foreign Relations, a contributing opinion writer for The New York Times. Krastev publishes extensively on international politics, including analyses of the political developments in EU, USA, Russia. He is the author of numerous publication and work about populism. His work includes analysis of populism in Greece and Europe as the whole. He recently published "Distinguishing Liberal Democracy's Challengers".
